#### TERMINATION

Either party may terminate this Agreement by giving written notice at least 7 (seven) days before the intended termination date. The Lender can also terminate this agreement without notice if the Borrower fails to comply with the Agreement's terms and conditions.

#### RELEASE AND WAIVER OF LIABILITY

In consideration of being permitted to borrow this equipment, the Borrower, for himself/herself, his/her personal representatives, heirs, and next of kin hereby releases, discharges, and covenants not to sue Lender, its employees, officers, directors, trustees, vendors and volunteers, on account of any loss or damage suffered from or related to the Borrower's utilization of the loaned equipment, including without limitation any injury to property, or injury to person. The Borrower also agrees to indemnify and hold harmless the Lender, its employees, officers, directors, vendors and volunteers from any such loss or damage incurred or caused by the Borrower.

The Borrower has read and voluntarily signs this Release and Waiver of Liability, and agrees to follow the Terms and Conditions, above.

#### GOVERNING LAW

This agreement shall be governed by the state laws of North Carolina.

#### ENTIRE AGREEMENT
