

American Legion Post 543 General Membership Meeting Minutes Wednesday, August 27, 2025

Meeting Minutes

- 1) The meeting was called to Order at 7:00 PM –Commander Michael Carton.
- 2) The Commander ordered the advancement of the Colors and a hand salute.
- 3) Opening Prayer Chaplain Templeman.
- 4) The Commander recognized the POWs and those Missing in Action, as well as honored them by referring to the empty chair.
- 5) The Pledge of Allegiance was led by the Commander with audience participation.
- 6) The Commander led the Members in reciting the Preamble to the American Legion Constitution.



- 16) The Commander requested a motion be made to approve August 27, 2025, Post 543 Finance Report. A motion by Post Member Aaron Largent and Seconded by Steve Muir was made to approve August 27, 2025, Post 543 Finance Report No discussion was required. The motion carried, and the voice vote was unanimous.
- 17) The Commander invited Gary Purcell (2nd Vice Commander, Membership) to the podium to provide the Membership with an update.
 - a. The 2nd Vice Commander informed the Post 543 Membership that the 2025-2026 Membership Goal for Post 543 is 269 Members.
 - b. The 2nd Vice Commander stated that 50% of Membership by 9/10/25 will not be a problem this year based on our current 2025-2026 Membership of Post Members that have renewed and the addition of 5 new Members this evening.
 - c. The 2nd Vice Commander informed the Members of a 2nd letter from National will be appearing in the Mail in early October to those that have not renewed.
- 18) The Commander invited Steve Muir (Post 543 Resource Officer) to give an update on the current active cases he is working on behalf of the Post.
 - a. The Service Officer Informed the Membership that the "MyHealthVet.com" will be shut down on September 30, 2025, and the members will need to log in to the VA using "Login.Gov" or "ID.Me.com"
 - b. The Service Officer informed the Membership Federal Electronic Health Record is being deployed to 13 new VA sites with all VA sites have access by 2031.
 - c. VA stated this week that the 29th Million Home Loan was provided this week.
 - d. The Service Officer informed the Membership that the VA has processed more VA Claims this year than ever before. The VA is processing the VA Claims in three days.
 - e. The Service Officer mentioned that Members of Post 543 accompanied him to provide a \$1,500 Check for the Veteran Smiles Program at the Novant Dental Clinic in Supply, NC. We also found that the Veteran Smiles Program is being transferred to the ECU College Dental School.
 - f. A new Case being revied is a Veteran Army MP currently working at Sunny Point Terminal. He injured his leg and is now in Light Duty Status. Post 543 provided \$409.58 for his car payment and \$2,000 to help him pay his Mortgage.

g. Service Officer Steve Muir informed the Post about a female Marine Veteran suffered a brain injury after being assaulted while on Active Duty. As a result of a misunderstanding this Veteran became behind on a number of different debts. In a showing of cooperation between Veteran Service Groups, 13 Veteran Service Organizations came together to provide approx. \$7,500 to help her with her College Tuition and other miscellaneous debts.

19)The Sergeant-at-Arms/House & Entertainment Report – Rick Sessa

- a. Sergeant-at-Arms Rick Sessa and the House and Entertainment team has arranged a Bus Trip to Ft. Bragg on November 5th. The Bus will leave the HWEC at 8:30am and return to HWEC at around 9:00pm. 40 passengers are required to attend, and the cost will be \$75 p/p.
- b. Rick Sessa reminded the membership of the Post 543 "Salute to Veterans Dance" at the Homer Wright Event Center on November 14th and tickets are available after the General Membership Meeting at \$15/p/p or \$25 per couple.
